### Terms:

- i. This is a turnkey works's contract for the supply and installation of cable trays at the above stations.
- ii. Prices quoted should be exclusive of local taxes (KVAT). However the rate of tax applicable for this turnkey work's contract should be stated taking into considerations the relevant provision of the Karnataka value added tax.
- iii. Schematic indicative Drawings are provided for reference.
- iv. A mockup of the cable tray should be made for approval for acceptance by the BMRCL/GC atleast in one station before proceeding with final assembly.
- v. Service charge as applicable on labour portion shall be extra, however, BMRCL is exempted from payment of service tax, the same may not be considered.
- vi. The rates quoted shall be inclusive of transportation. The bidder has to consider the Transportation Charges while quoting.
- vii. The prospective bidders are requested to go through the specification of cable trays, cable tray manufacturer qualifying requirements, terms and conditions of the contract, etc. while quoting.
- viii. The Tender documents may be obtained from the front desk of BMRCL at free of cost and the sealed bids shall be submitted during office hours as detailed below.
