## CALL FOR SEALED QUOTATIONS FOR DISPOSAL OF IRON SCRAP

Sealed quotations are invited from working/registered/local contractors for disposal of following scrap iron items.

### Terms & Conditions:

- I. The material is scrap and the condition is as and where is basis.
- II. The items shall be lifted from the location where they are available by the shortlisted tenderer.
- III. No transportation shall be provided nor shall transportation charges be paid for transportation of materials put to bid from the site of available barricades to bidder's premises or requirement or weightment.
- IV. The successful bidder shall pay the full amount of the bid and obtain a letter of award for moving of materials put on bid.
- V. The prospective bidders may visit the site and ascertain the extent of materials available.
- VI. The material shall be weighed at designated weigh bridge decided in presence of BMRCL representative(s) before the items are handed over to the successful bidder.

- VII. The successful bidder shall make arrangements at his cost for transportation for full quantity weightment of materials before they are handed over after finalization.
- VIII. The total cost of materials shall be computed on the quoted rate and the total cost shall be deducted from the deposited amount and the balance amount shall be returned back to the successful bidder once the material is weighed and the BMRCL representative issues a certificate of disposal to the successful bidder.
- IX. In case the material amount based on the bid exceeds the deposit amount the bidder has to deposit the additional amount to BMRCL immediately for issue of clearance to take the material to his custody. In case he falls, the bidder shall be disqualified and 25% of the amount of deposit would be forfeited.
- X. The deposit amount of the unsuccessful bidders shall be returned on successful opening of the bid on the bid opening day at the bid opening venue, if the authorized representative(s) are present for bidding on establishing the identity of the bidder.
- XI. BMRCL reserves right to cancel the bid and abandon the bidding process at any point and return the deposit amount to the bidders without any interest.
- XII. The bidders shall quote "rate per Kg" only and the quote written in words would be final in case of discrepancy between figure & words.
- XIII. If the successful bidder fails to come forwarded to lift the materials within 7(Seven) days from the date of acceptance of the bid and issue of acceptance letter by BMRCL, 25% of the deposit amount would be deducted as contract security and the balance would be returned.
- XIV. BMRCL reserves right to award the bid to Highest-2 bidder at Highest-1 bid price if agreeable to Highest-2 bidder, if the Highest -1 bidder refuses to honour the bid commitment of lifting the materials within 7(Seven) days from date of issue of letter or otherwise fails. An equivalent Amount of 25% of the deposit amount would be forfeited by Highest-1 bidder.
- XV. BMRCL may retain to hold back the deposit amount of Highest-2 bidder for a period till the transaction is complete.
- XVI. **The deposit amount of Rs. 2 Lakhs shall be furnished along with the quotation in the form of Crossed DD payable to BMRCL at Bangalore. There would not be any interest payable to the bidder for the deposit amount held back by BMRCL.**



- XVII. The bidder would be disqualified, if the requisite DD is not found enclosed along with the quotation in the sealed quotation.
- XVIII. The quotation once submitted cannot be withdrawn.
- XIX. The bidder may be represented by the authorized representative on authority letter from the bidder along with photo identity which shall be produced.
- XX. The prospective bidders shall produce the photo identity for participating in the bid.
- XXI. Each bidder shall be permitted to participate in the bid, but the maximum number of representatives shall not be more than 2 persons.
- XXII. On the total bid price (gross sale value) taxes as applicable will be charged.**
- XXIII. The bid form is on sale from the date of this notification till the office closing hours on date notified below and the quotations would be opened on the notified date and time at BMRCL corporate Office at Shantinagar, Bangalore.
- XXIV. In all other matters other than those brought out in this notification the decision of MD, BMRCL or the nominee of MD, BMRCL is final and not questionable.
- XXV. If there is any dispute arising it shall be within the jurisdiction of Bangalore Urban Courts.
