**BANGALORE METRO RAIL CORPORATION LIMITED invites sealed tenders in three envelop system (i.e separate envelop for EMD, Technical bid and Price bids) **eligible bidders for the works mentioned below on turnkey basis for** Tender Document for Modification of Existing 66KV Line towers with suitable 220KV Double circuit Narrow Based tower in 66 KV Peenya DG plant 1&2, 66 KV Peenya DG plant 3&4 Line crossing over the proposed METRO corridor near CMTI on NH-4 to obtain adequate vertical clearance between Railway Track & 66KV Lines.**

The Scope of the work covers the following:

- i. Concreting of new 220 KV Double Circuit Narrow based Towers by the side of the existing Towers as per the survey report.
  - ii. Releasing of the conductor, Dismantling of Existing Towers.
  - iii. Erection of new Towers, Restrunging of conductor and commissioning.
- A. Bids not covering the entire specified scope shall be treated as incomplete and rejected. It is a fixed price contract.
- B. The Interested eligible bidders may obtain further information on BMRCL site [www.bmrc.co.in](http://www.bmrc.co.in). The documents would be available on prescribed payment from **28.01.2012 to 13.02.2012** during office working hours.
- C. A complete set of bid documents on payment of non-refundable fee of Rs5,000/- in the form of DD/pay order favoring BMRCL, payable at Bangalore by sending a request through highlighting the case of any difficulty or clarifications the same can be obtained from the Chief Engineer Electrical (Traction), BMRCL, III Floor, BMTCL Complex, K.H.Road, Shanthinagar, Bangalore-560 027 on all working days during the working hours till the date of sale of documents
- D. Completed Bids shall be submitted along with the EMD in the form of Demand Draft as mentioned against EMD column of each enquiry. The EMD shall cover the entire validity period of the bid including period of extension if any, required by BMRCL.
- E. Bids shall be submitted in 3 envelops viz. (i) The EMD (ii) Technical Bid (iii) Price Bid, both technical & Price bids shall be in duplicate in separate sealed covers. All the three enclosed in an outer sealed cover.

- F. Sealed Bids will be received on **13.02.2012** between **11:00 hours to 15.00 hours** .The technical bids will be opened in the presence of the bidder or his authorized representative who choose to attend at the office of BMRCL on **13.02.2012 at 15.30 Hrs.** If the office happens to be closed on the last day of issue or receipt of the bids for any reason, the bids will be issued or received and opened on the next working day of the office at the same venue and time.
- G. The Price bids of technically qualified bidders will be opened at a later date under intimation to such bidders only in the presence of bidders/representatives who choose to be present. Bid security of bidders not technically qualified will be returned through registered post only after award of the contract to the successful bidder.
- H. The bidder shall provide credentials in support of the technical capability, financial strength and past experience by supporting documents / client certificates / CA's audit reports.
- I. BMRCL takes no responsibility for delay, loss or non-receipt of bid document sent by post / courier /either way. Further, BMRCL reserves the right to reject any or all the bids without assigning any reasons thereof and shall bear no liability whatsoever consequent to upon such a decision.

J. **Financial/Technical Eligibility Criteria for Bidders:**

- i) The Bidder should possess a valid "Electrical Class I license" issued by the Electrical Inspectorate, Government of Karnataka duly supported by a copy of the certificate(Original document of the license will have to be produced for verification by BMRCL within five days of opening of the Technical bid).
- ii) The bidder should have experience in construction of 220KV or 66KV over head transmission lines with narrow based/regular towers concreting and erection, stringing and commissioning during the last five years ending 31.12.2011 as detailed below one work of value not less than 80% of the estimated cost i.e. Rs. 42,80,639.00/-(Rupees Forty Two Lakhs Eighty Thousand Six Hundred Thirty Nine only)

**Or**

Two works each of value not less than 50% of the estimated cost i.e. Rs. 26,75,400/-(Rupees Twenty Six Lakhs Seventy Five Thousand and four Hundred only).The Bidder shall furnish clients' certificates in support of the same.

**Or**

Three works each of value not less than 40% of the estimated cost i.e. Rs.21,40,320/-(Rupees Twenty One Lakhs Forty thousand and Three Hundred Twenty only). The Bidder shall furnish clients' certificates in support of the same.

- iii The bidder should have an average annual turnover of the last three years ending 31.12.2012,i.e.Rs.66,88,498/-(Rupees Sixty Six Lakhs Eighty Eight Thousand and Four Hundred Ninty Eight only). The Bidder shall furnish clients' certificates in support of the same.
- iv The Bidder should not have history of litigation and should not have been black listed by KPTCL / BESCO or erstwhile KEB or by any department of Government of Karnataka and any other Central Government department including PSUs. An undertaking to that effect shall be furnished.
- k. The Bidder shall furnish copies of audited and certified financial reports in support of the same, for the financial years 2008-09, 2009-10 and 2010-11. If the copies of audited and certified financial reports for 2010-2011 are not available, then the bidder shall furnish copies of audited and certified financial reports of 2007-08, 2008-09 and 2009-10.
- L. The Bidder shall furnish documentary evidence in support of the qualifying requirements stipulated above.
- M. Issue of Bid document will not automatically mean that Bidders are considered qualified, and it is subject to evaluation by BMRCL. Intending parties who fulfill the qualifying requirements are advised to visit the site to familiarize themselves with the nature of work & site conditions.
- N. Time is the essence of this contract. Period of completion is 120 days from the date of issue of letter of Award (LOA).
